CONDITIONS OF CONTRACT

1. Exhibitor agrees to abide by all the regulations and rules adopted by Northwest Agricultural Show (NWAS), a division of EO Media Events LLC (EOME), doing business as Northwest Agricultural Show (NWAS) in the best interest of the Show, and agrees that NWAS Management shall have the final decision in adopting any rule or regulation deemed necessary prior to, during and after the Show.
 2. Exhibitor will be liable for and will indemnify and hold harmless NWAS, NWAS Management, and EOME, from any loss or damages whatsoever as a result of any person or company including, without limiting the generality of the foregoing, Exhibitor, other Exhibitors, NWAS Management, the owner of the property and their respective agents, servants and employees and members of the public participating in the Show, if said loss or damages arose or were in any way connected with the Exhibitor's digital space.
 3. This agreement may be cancelled by either party provided written notice is received by the other at least 60 days before the beginning of the Show in which case all monies paid by Exhibitor will be refunded. If Exhibitor cancels between 61 and 30 days before the beginning of the Show, Exhibitor will be liable for 50% of the total contracted costs, plus applicable taxes. If Exhibitor cancels within 30 days of the beginning the Show, Exhibitor will be liable for 100% of the total, plus applicable taxes. In the event NWAS is cancelled for any reason, Exhibitor waives any and all damages and claims for damages, and agrees that the sole liability of NWAS Management shall be to return to each digital space payment, less Exhibitor prorated share of all costs associated and expenses incurred and committed by NWAS Management. By cancelling this agreement Exhibitor forfeits all rights or claims to NWAS Management.
 4. Digital space contracted by Exhibitor represents a nonexclusive license to occupy such digital space and may not be sublet.
 5. NWAS Management reserves the right at any time to alter or remove digital content or any part thereof, and to expel Exhibitor or its personnel and to immediately cancel this agreement if, in NWAS Management's opinion, their conduct or presentation is objectionable to other Show participants or if Exhibitor or anyone on its behalf makes any deception or misrepresentation as to the products or services offered.
 - a. Exhibitor is responsible for complying with all applicable federal, provincial and municipal laws and licenses with respect to its products and digital exhibit.
 - b. Exhibitor is responsible for collecting and remitting to the appropriate government authorities all sales and other taxes as applicable with the respect to the sale of products, or services from the exhibit or concession(s).
 - c. Exhibitor will provide all government inspectors or agents all information required in the conduct of their investigations and will not impede or overrule the work of any government inspector in any area of their jurisdiction.
 - d. Exhibitor shall not conduct a free draw unless prior approval from NWAS Management has been obtained Exhibitor will provide NWAS Management with the name of the winners of any free draw conducted. The Exhibitor is responsible for conducting all free draws in accordance with applicable laws.
 6. NWAS Management reserves the right at its sole discretion to change the platform and date or dates upon which the Show is to be held and shall not be liable in damages or otherwise by reason of any such change. In the event that the digital space to be used by Exhibitor is in any way rendered unusable, NWAS management is not liable therefore in any matter whatsoever.
 7. NWAS Management reserves the right to cancel this agreement if Exhibitor fails to perform any material condition of this agreement or refuses to abide by the Show rules and regulations, in which case Exhibitor shall forfeit payments made by Exhibitor and any further occupancy of such space.
 8. The Exhibitor gives us the right to forward contact information to our official suppliers.
 9. All videos and/or content produced by EOME are the sole property of NWAS and EOME and their respective agents.
